Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. Dispute Act, 1947 or Contract Labor (Regulation & Abolition) Act, 1970. Undertaking from the persons to this effect shall be required to be submitted by the service provider to this Department.

4. The service provider's personnel shall not divulge or disclose to any persons of any details of office, operation process technical know-how, security arrangements, Administrative/organization matters as all are confidential/secret in nature.
5. The service provider's personnel working should be polite, cordial, positive and efficient while handling the assigned work and their action shall promote goodwill and enhance the image of this Department. The service provider shall be responsible for any act of indiscipline on the part of the personnel deployed by him.
6. That the personnel deployed shall not be below the age of 18 years and they shall not interfere with the duties of the employees of this Department.
7. Computer knowledge of service provider's personnel shall be checked before they are deployed to the work and any personnel found not suitable thereupon shall be forthwith replaced by the service provider.
8. The department may require the service provider to dismiss or remove from the site of work, any person, or persons, employed by the service provide, who may be incompetent or for his/her/their misconduct and the service provider shall forthwith comply with such requirements.
